Superintendent's Report

Facilities Update:

Over the Winter Break maintenance was able to complete several projects. The
dehumidifier was installed underneath the Toddler Center; the Bogen System was repaired
in several classrooms and electrical outlets installed in the new staff lounge. Room 32 had
the floor polished, the playground lines were painted at Chinese Camp, and the
kindergarten trike shed is nearly complete. We also had the mandatory walk through for
prospective bids for the Prop 39 Energy Efficiency Project.

• Traffic Slowing Devices:

I met with Tonya Allen the Supervising Engineer at the Tuolumne County Community Resources Agency about options and procedures regarding traffic calming devices. We have several options to consider and I will bring them to our next Board Meeting as a discussion/action item.

• Staffing:

Selection of candidates and interviews scheduled for our four open positions will occur within the next week. We have two special education paraprofessionals, the library clerk, and one after school teacher. We used Indeed.com and seemed to get a much higher candidate response. Looking forward to a good interview pool and selecting great additions to our team.

• Low Performing Student Block Grant

This is a state allocation to provide support for our low performing students with additional supports to increase their academic achievement. These students are not represented in our unduplicated count. Our allocation is \$21,000 that represent 11 students, and it is required that we develop an implementation plan. Administration and the Leadership Team are developing the plan and will be brought to you for an action/discussion item in February. The adopted plan will then be reported to the State Superintendent by March 1st.

• Jamestown Promotion Club-Teacher of the Year

Congratulations to Linda Cazares for being selected as the Jamestowns Promotions Club's Teacher of the Year. The dinner will be at the Jamestown Hotel on January 17, 2019 beginning at 5:00 p.m.

• Chicken Ranch Rancheria Band of Mi Wuk Indians

The tribe has graciously, donated \$22,000 to Chinese Camp playground improvements. They also, just recently, again, will donate around \$30,000 to be shared with Chinese Camp and Jamestown Elementary School.

- <u>The Winter concert</u> with the 4th-8th grade students was wonderful. The students really showed their musicality and pride. Turnout was very good.

- 3. Must not receive any further severe behavior infractions or education code violations specifically alcohol/drug related and/or threatening language or behavior towards peers or staff
- 4. Maintain a 2.5 or better GPA

Prior to March 25, 2019 there will be a team meeting with the staff of TLC and Jamestown School District administration and teacher(s) to review and discuss the progress of the student in meeting the conditions of the rehabilitation plan and determining if the student may return to Jamestown School for the rest of the 2018-2019 school year. If the team agrees, a transition plan will be developed and implemented for return on April 1, 2019 with three conditions:

1. Continue weekly counseling and family counseling at least once a month

- 2. No severe behavior infractions or education code violations specifically drug/tobacco/alcohol related
- 3. Maintain a 2.5 GPA

If any one of these conditions are not met, the expulsion is reinstated and the student will return to TLC immediately.
