

LCFF funds include a base level of funding for all LEAs and extra funding - called "supplemental and concentration" grants - to LEAs based on the enrollment of high needs students (foster youth, English learners, and low-income students).

Budget Overview for the 2019-20 LCAP Year




This chart shows the total general purpose revenue Jamestown School District expects to receive in the coming year from all sources.

The total revenue projected for Jamestown School District is \$4,652,491.00, of which \$3,950,646.00 is Local Control Funding Formula (LCFF), \$227,659.00 is other state funds, \$310,253.00 is local funds, and \$163,933.00 is federal funds. Of the \$3,950,646.00 in LCFF Funds, \$769,294.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The LCFF gives school districts more flexibility in deciding how to use state funds. In exchange, school districts must work with parents, educators, students, and the community to develop a Local Control and Acccountability Plan (LCAP) that shows how they will use these funds to serve students.

This chart provides a quick summary of how much Jamestown School District plans to spend for 2019-20. It shows how much of the total is tied to planned actions and services in the LCAP.


Jamestown School District plans to spend \$4,908,313.30 for the 2019-20 school year. Of that amount, \$769,294.00 is tied to actions/services in the LCAP and \$4,139,019.30 is not included in the LCAP. The budgeted expenditures that are not included in the LCAP will be used for the following:

Increased or Improved Services for High Needs Students in 2019-20

In 2019-20, Jamestown School District is projecting it will receive \$769,294.00 based on the enrollment of foster youth, English learner, and low-income students. Jamestown School District must demonstrate the planned actions and services will increase or improve services for high needs students compared to the services all students receive in proportion to the increased funding it receives for high needs students. In the LCAP, Jamestown School District plans to spend \$769,294.00 on actions to meet this requirement.
