6.1 Jamestown Teachers Association Agreement

The Board will consider ratifying a tentative bargaining agreement between the Jamestown School District and the Jamestown Teachers' Association for the 2021/2022 school year.

PUBLIC HEARING

The Board will hear comments about a tentative agreement between Jamestown School District and the Jamestown Teachers' Association for the 2021/2022 school year. This tentative agreement is as follows:

- a. *An increase of 1.5 % to the current certificated salary schedule for the 2021/2022 school year*
- b. *The addition of a stipend of \$1300 for Special Education Coordinator to the schedule and adding \$100 to each activity on the stipend schedule*
- c. *An increase in the per hour rate for professional duties or development outside of the bargaining agreement from \$30/hr. to \$40/hr.*

- d. All bargaining unit members who have over 90 units will be paid at the rate of \$70 per unit up to a maximum of 125 units
- e. An increase of \$200 to the health and welfare cap for a total of \$9200, a 2.3% increase.
- f. Agreement to the grade span adjustment (GSA) annual average class enrollment for grades K-3 for the next three-year contract. Certificated teachers in grades K-3 that have over 24 students enrolled in their classroom for at least a three-month period at any time during the school year, will receive a one-time stipend of \$500 for enrollment up to 26 students and an additional one-time stipend of \$250 for an enrollment of 27 students.
