Since March of 2020, Jamestown School District regularly provided information to stakeholders (e.g. students, parents, certificated staff, classified staff, management/administrators, school site council, school board) through district informational letters and sent out through our SIS autodialer system or email. All stakeholders (e.g. students, parents, certificated staff, classified staff, management, administrators) were provided the opportunity to give feedback through participating in multiple surveys, contacting the Superintendent directly by phone and/or email, and through a standing Board agenda discussion item open to public comment. For those families that speak Spanish, our messages and letters are translated, and our bilingual staff are available to respond to and answer questions. and The District held tele-conferencing meetings through Zoom both for school site council, parent meetings, and Board meetings. All stakeholder input and feedback were taken into consideration for the development and alignment of the Learning Continuity and Attendance Plan, the 2021-2022 LCAP, and now this ESSER III Expenditure Plan. Along with many school staff meetings held between August 2021-September 2021 to identify priority needs

and how best to use ESSER funds to directly impact students, families and the local community, an additional survey specific to the use of ESSER III funds was distributed to all district stakeholders in September. In addition, Jamestown School District also sought input from individuals and/or agencies representing the interests of Tribal Youth, Homeless and Foster Youth, youth who are low-income, youth who are incarcerated, students with disabilities, students of color, and students who are English Learners. Input was also received from community organizations and partners such as the Yes Partnership and ATCAA, the Amador-Tuolumne Community Action Agency. This outreach occurred during the time period of September 8-September 17, 2021. A survey for written responses was created and distributed during a meeting of the Student Attendance Review Board Members, which represent a number of agencies working with youth in the community, and with follow up emails as well as direct outreach to other community agencies and representatives through email and phone calls. Jamestown School District evaluated its stakeholder engagement opportunities and determined that Civil Rights Groups/ Migratory Students are neither present nor served by the LEA.

### A description of how the development of the plan was influenced by community input.

Feedback from all stakeholder groups (e.g. students, parents, certificated staff, classified staff, management, administrators, school site council, school board) was incorporated into the development of the actions and strategies addressing the loss of instructional time and providing supplemental instruction and support to identified students and are reflected in the ESSER III Expenditure Plan. This additional feedback is consistent and aligned with past input on the ELO and LCAP, with top priorities including maintaining in-person learning safely and preventing school closure (63.2%), increasing counseling and mental health supports (80.6%), increasing student engagement and addressing learning loss in reading and math through extended learning and intervention supports (83.9%).

The development of this ESSER III expenditure plan was influenced by input received from students, families, school personnel, community organizations and representatives of student groups identified above in the following ways:

Biggest challenges in addressing learning loss and accelerating learning: 41.9% student engagement and motivation and 25.8% responding to the need to address student social-emotional needs first.

Highest priority needs are: 83.9% academic, 67.7% social emotional supports, 58.1% mental health concerns and resources, and 38.7% the need for more extended learning and intervention support.

What strategies have been the most effective in supporting the needs of students: Return to in-person learning 77.4%, Counseling/Mental Health services 51.6%, additional intervention supports and personnel 48.4%, extended learning opportunities 45.2%, and availability of technology resources and devices 41.9%.

Community feedback focused on the following areas:

Bridging barriers to learning by meeting the students where they are
Using trauma informed practices and teaching social emotional learning skills
Increasing counseling services and mental health supports
Supporting families by building positive relationships with parents and providing resources
Collaborating with community agencies regarding substance abuse education, identification and interventions

Identifying and addressing a lack of basic needs such as housing and health care
Making translators more readily accessible for communication with our Spanish speaking families
Increasing opportunities for students with disabilities to be in the least restrictive environment with access to grade/age appropriate peers

# **ESSER III Expenditure Plan Instructions**

#### Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

- **Tier 4 Demonstrates a Rationale**: practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

  - Tracking student attendance and improving student engagement in distance education;

### **Planned Actions and Expenditures**

## **Purpose and Requirements**

As noted in the Introduction, an LEA receiving ESSER III funds is required to develop a plan to use its ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

#### Instructions
